ST JOHNS COUNTY VETERANS' TREATMENT COURT















Veterans Treatment Supervision was created by the Florida Legislature in 2012 with the creation of Florida Statute 948.08(7)(a), which has been an integral part in the establishment of numerous Veterans Treatment Courts (VTC) throughout Florida.

The VTC is a non-traditional approach to criminal offenders who have served both during peace and wartime. Rather than focusing only on the crimes they commit and the punishments they receive, VTC also attempts to solve some of the participants' underlying health, substance abuse and psychosocial problems. It is a program that structures the treatment of veterans around the authority and personal involvement of a single VTC Judge. Veterans Treatment Court is also dependent upon the creation of a non-adversarial courtroom atmosphere where a single judge, dedicated court staff, the treatment team, and the Mentors work together toward the common goals of breaking the cycle of substance abuse and criminal behavior, and addressing mental and physical health issues. An environment with clear and certain rules is created, and each participant's compliance is within his or her own control.

It has come to light that too many former service members were having a hard time re-entering the civilian population for many reasons. Post-Traumatic Stress Disorder (PTSD), Injury, Disability, Substance Abuse, other Mental Health problems, compounded by the lack of jobs, family and housing issues, and other social obstacles have taken their toll on Veterans from many wars and conflicts.

After four years in the making, the St Johns County Veterans Treatment Court was christened on January 2017 in a Ceremonial session where the 7th Judicial Circuit Chief Judge Terence Perkins officially opened the SJC VTC, which will be presided over by Circuit Judge Howard McGillin.

The VTC Team is comprised of the Judge, a VTC Coordinator, a 7th Judicial Circuit Coordinator, an Assistant District Attorney, a Public Defender, and a Veterans Justice Outreach Specialist, plus other local and VA resources and service providers. Veterans entered into the VTC are referred to as "Participants."

There is also a supplementary Mentor Team, composed of volunteer veteran "Mentors." Each Participant in the program is assigned a Mentor, to serve as a friend, a shipmate, a wingman, a battle buddy, to assist that Participant navigate and forge ahead to the finish line. This is one key to the success of the program. The veteran is not alone. His or her Mentor is there for them every step of the

way. A strong bond is forged between the Mentor and the Participant. Working together, nearly all veterans can successfully complete the mandated program, reintegrate with the community, and go back to their normal lives.

Since that January 2017 kickoff, we have now completed eight court sessions, and have grown from four to nineteen veteran Participants. We started with five Mentors and now have six active Mentors with four others in various stages of training and qualification. Vietnam Veterans account for half of our current Mentor corps.

In recognizing that these are the men and women who have placed their lives "in harm's way" to defend the United States of America, we owe them a second chance. Being referred to a Veterans Court, in most cases, will give them that second chance.

WHITE HOUSE VA HOTLINE

The VA announced that starting October 15, the White House VA Hotline—855-948-2311 will be operational 24 hours a day, seven days a week. The pilot phase demonstrated that veterans calling the hotline respond best when their calls are answered by fellow veterans and others with first-hand experience on their issues. As a result, the VA is targeting highly qualified veterans to staff the hotline going forward, instead of contracting the service to a third-party vendor, and has hired additional VA personnel to complete the planned move to a 24-hour operation.





VETERANS ONLINE SHOPPING BENEFIT



The military exchanges have been ramping up their stock and shoring up their websites' capability as they prepare to launch the Veterans Online Shopping Benefit on **November 11**, potentially opening up their online, tax-free stores to millions of new customers.

More than 235,000 veterans had been verified to begin shopping at the online military exchange websites as of Oct. 30, but it's estimated that 18 million new shoppers are eligible for the benefit, which was approved by the Defense Department in January. It's available to all honorably discharged veterans

of U.S. armed forces; veterans should visit **www.vetverify.org** to verify their eligibility before trying to shop.

It applies only to online exchange shopping, not to shopping in brick-and-mortar stores, and it doesn't extend to veterans' dependents.

The websites are: www.shopmyexchange.com; www.mynavyexchange.com; & www.shopcgx.com. Any eligible shopper can shop at any of the websites. Actual exchange prices aren't visible until you log in as an authorized shopper, and you don't have to add sales tax.

THE BIRTH OF THE UNITED STATES MARINE CORPS

VIETNAM VETERANS OF AMERICA







According to tradition, Tun Tavern in Philadelphia, PA was where the United States Marines held their first recruitment drive. On November 10, 1775, the Second Continental Congress commissioned the innkeeper Samuel Nicholas to raise two battalions of Marines in Philadelphia. The tavern's manager, Robert Mullan, was the "chief Marine Recruiter." The first Continental Marine company was composed of one hundred Rhode Islanders commanded by Captain Nicholas.

Each year on November 10, U.S. Marines worldwide toast the memory of this colonial inn as the officially-acknowledged birthplace of their service branch. The earliest Marines were deployed aboard Continental Congress Navy vessels as sharpshooters because they were typically recruited as outstanding marksmen.

Founded in 1775, the United States Marine Corps shares its legacy with that of the United States of America. Intrinsically bound, the Marines have fought with courage and valor in every war, every police action, every armed conflict – whatever one might call it - to defend our constitution, protect our people, and to stabilize the world in times of crisis.

To all active duty and former Marines, the Vietnam Veterans of America Leo C. Chase Chapter 1084 extends a hearty Semper Fidelis and HAPPY BIRTHDAY to the UNITED STATES MARINE CORPS!
