Florida's population of Vietnam Veterans is estimated to be approximately 580,000, but the total number of those Vietnam Veterans in the 30 Chapters of the VVA spread throughout Florida is 4482 members; approximately 0.75% of that large population. Translating those statistics to St Johns County would imply that for every card-carrying VVA 1084 members, there are approximately 105 eligible Veterans having coffee at Starbucks, or shopping in Publix, or in the CBOC waiting room, just waiting to be recruited. ### THIS MONTH IN MILITARY HISTORY

February holds these significant dates in U.S. Military History: Can you remember where you were?

- **1 February 1967** Operation Prairie II was begun in Quang Tri province by elements of the 3rd Marine Division. During the 46-day search-and-destroy operation which terminated 18 March, 93 Marines and 693 of the enemy were killed.
- **3 February 1994** Nearly two decades after the fall of Saigon, U.S. President Bill Clinton announces the lifting of the 19-year-old trade embargo against Vietnam, citing the cooperation of Vietnam's communist government in helping the United States locate the 2,238 Americans still listed as missing in the Vietnam War.
- **9 February 1968 USCG** vessels helped thwart a Communist attempt to run four trawlers through the Market Time blockade off the coast of South Vietnam. The defeat of this attempted re-supply was hailed as "the most significant naval victory of the Vietnam campaign."
- 11 February 1973 First release of American prisoners of war from Vietnam takes place. [I was embarked in USS Enterprise in the Gulf of Tonkin and was airborne on this date in participating in this beginning of "Operation Homecoming."]
- **12 February 1955** President Eisenhower sends first U.S. "advisors" to South Vietnam to aid the government under Ngo Dinh Diem.
- 19 February 1945 the Battle of Iwo Jima begins. [When this battle was won, the Fleet Admiral had this to say: "The battle of Iwo Island has been won. The United States Marines by their individual and collective courage have conquered a base which is as necessary to us in our continuing forward movement toward final victory as it was vital to the enemy in staving off ultimate defeat." -- Chester W. Nimitz]
- **21 February 1974** A report claimed that the use of defoliants by the U.S. had scarred Vietnam for a century. Defoliation was meant to save lives by denying the enemy cover.
- **24 February 1991** Operation Desert Storm ground war begins.
- 26 February 1973 The first airborne mine sweep in a live minefield took place in the Haiphong ship channel by helicopters from Helicopter Mine Countermeasures Squadron Twelve on board USS New Orleans. [This "mine sweep" was clearing mines in the waters approaching Haiphong Harbor that I along with numerous other aircraft from four deployed Aircraft Carriers laid on 30 December 1972.]
- **28 February 1962** The 39th Signal Battalion, a communications unit, is the first unit of U.S. regular ground forces to arrive in Vietnam.
- **28 February 1991** Operation Desert Storm ground war ends after 100 hours.

### SNIPPETS FROM THE FLORIDA STATE COUNCIL CONFERENCE 9-10 FEBRUARY 2018

1. **RAMP**: On November 2, 2017, the Department of Veterans Affairs rolled out RAMP, the first opportunity for veterans to enter the **new appeals process** outlined in the **Veterans Appeals Improvement and Modernization Act of 2017**.

The Act will not take full effect until February 2019. But the new program – RAMP, which stands for **Rapid Appeals Modernization Program** – will allow veterans currently appealing their claims to participate in *some*, *but (importantly) not all* parts of the new appeals system.

This new system is intended to streamline the VA's current appeals process (now referred to by the VA as the "legacy" appeals process), which has received ample criticism for its inefficiency and excessive wait-times. The new process will allow veterans to choose from three different review lanes.

By February 2019, all appeals should be processed under the new system. For now, though, veterans who want to appeal a VA decision can choose to remain in the legacy appeals process or participate in RAMP.

The wording above is from a VA website. The cautions below come from Marc McCabe, VVA Bureau Chief/Regional Director and VVA VSO:

### Some facts on RAMP,

- "... this is the new VA program designed to confuse and deny veterans benefits at the appeal level. 1) The so called "duty to assist" goes away. 2) the timing if you opt in, the VA will not ... look at the appeal until Feb 2019, 3) once you opt in you can't opt out and all appeals are opted in, 4) You cannot submit any New and Material evidence once you opt in, and 5) the complete regulations still haven't been formulated by the VA."
- 2. **The Genome Program, or, the Million Veteran Program (MVP):** MVP is a national, **voluntary** research program funded entirely by the Department of Veterans Affairs Office of Research & Development. The goal of MVP is to partner with Veterans receiving their care in the VA Healthcare System to study how genes affect health. To do this, MVP will build one of the world's largest medical databases by collecting blood samples and health information from one million Veteran volunteers. Data collected from MVP will be stored in a secure manner and will be coded for researchers so that they cannot directly identify you. Researchers will study diseases like diabetes and cancer, and military-related illnesses, such as post-traumatic stress disorder.

Marc McCabe cautioned that participation in this program could possibly lead to a reduction of benefits and cited one such case (maybe the MVP data is not stored as securely and as coded as they claim).

Before participating in either program, one should research for themselves and seek information from the VA and/or your local Veteran Service Officers (VSOs).





### VIETNAM VETERANS MEMORIAL FUND "IN MEMORY" PROGRAM



The Vietnam Veterans Memorial Fund (VVMF) is the nonprofit organization that founded the Vietnam Veterans Memorial (The Wall) in Washington, D.C. in 1982. They partner with the National Park Service to maintain and care for The Wall, The Three Servicemen statue, flagpole, and the *In Memory* plaque.

So, what is the *In Memory* program? VVMF's *In Memory* program honors Vietnam veterans whose lives were cut short as a result of their service in Vietnam but are not eligible for inscription on The Wall under DoD guidelines. *In Memory* is a way that all Vietnam veterans can be honored on the National Mall.

Examples of causes of death that fit the criteria for inclusion in the program include:

- Exposure to Agent Orange
- PTSD/suicide
- Cancer
- Diabetes
- Heart Disease
- Parkinson's Disease

*In Memory* began in 1999 and has since honored more than 3200 veterans. The In Memory Honor Roll has a remembrance page for each veteran and can be seen online at: <a href="www.vvmf.org/honor-roll">www.vvmf.org/honor-roll</a>

How to apply to the Program?

The application process is simple. To have a loved one honored in the *In Memory* program, please visit VVMF online at: <a href="https://www.VVMF.org/InMemory\_Apply">www.VVMF.org/InMemory\_Apply</a>

All you need to do is fill out the simple form, but you will need the following materials:

- Military Records that show proof of service in Vietnam (DD214)
- A copy of the death certificate
- Two clear photographs of the honoree. The VVMF recommends that one photo be from when the honoree was serving in the military and on photo that is more recent.

If you do not have or cannot find the required military service records they can be obtained from the National Archives Veterans Service Records. Visit <a href="www.archives.gov">www.archives.gov</a> and click on "Veterans' Service Records"

As of 31 December 2017, we were at 80 VVA members, which is up from 65 at mid-year 2017. Growth means more talent, more ideas, more boots on the ground, and a stronger financial base to run our programs and assist those Veterans most in need of help.
