### Starting Jan. 17, Veterans in suicidal crisis can go to any VA or non-VA health care facility for free emergency health care



WASHINGTON – Starting Jan. 17, Veterans in acute suicidal crisis will be able to go to any VA or non-VA health care facility for emergency health care at no cost – including inpatient or

crisis residential care for up to 30 days and outpatient care for up to 90 days. Veterans do not need to be enrolled in the VA system to use this benefit.

This expansion of care will help prevent Veteran suicide by guaranteeing no cost, worldclass care to Veterans in times of crisis. It will also increase access to acute suicide care for up to 9 million Veterans who are not currently enrolled in VA.

Preventing Veteran suicide is VA's top clinical priority and a top priority of the Biden-Harris Administration. This effort is a key part of VA's 10-year National Strategy for Preventing Veteran Suicide and the Biden-Harris administration's plan for Reducing Military and Veteran Suicide. In September, VA released the 2022 National Veteran Suicide Prevention Annual Report, which showed that Veteran suicides decreased in 2020 for the second year in a row, and that fewer Veterans died by suicide in 2020 than in any year since 2006.

"Veterans in suicidal crisis can now receive the free, world-class emergency health care they deserve — no matter where they need it, when they need it, or whether they're enrolled in VA care," said VA Secretary for Veterans Affairs Denis McDonough. "This expansion of care will save Veterans' lives, and there's nothing more important than that."

VA has submitted an interim final rule to the federal register to establish this authority

under section 201 of the Veterans Comprehensive Prevention, Access to Care, and Treatment (COMPACT) Act of 2020. The final policy, which takes effect on Jan. 17, will allow VA to:

Provide, pay for, or reimburse for treatment of eligible individuals' emergency suicide care, transportation costs, and follow-up care at a VA or non-VA facility for up to 30 days of inpatient care and 90 days of outpatient care.

Make appropriate referrals for care following the period of emergency suicide care.

Determine eligibility for other VA services and benefits.

Refer eligible individuals for appropriate VA programs and benefits following the period of emergency suicide care.

Eligible individuals, regardless of VA enrollment status, are:

Veterans who were discharged or released from active duty after more than 24 months of active service under conditions other than dishonorable.

Former members of the armed forces, including reserve service members, who served more than 100 days under a combat exclusion or in support of a contingency operation either directly or by operating an unmanned aerial vehicle from another location who were discharged under conditions other than dishonorable.

Former members of the armed forces who were the victim of a physical assault of a sexual nature, a battery of a sexual nature, or sexual harassment while serving in the armed forces.

Over the past year, VA has announced or continued several additional efforts to end Veteran suicide, including establishing 988 (then press 1) as a way for Veterans to quickly connect with caring, qualified crisis support 24/7; proposing a new rule that would reduce or eliminate copayments for Veterans at risk of suicide; conducting an ongoing public outreach effort on firearm suicide prevention and lethal means safety; and leveraging a national Veteran suicide prevention awareness campaign, "Don't Wait. Reach Out."

### MINUTES OF GENERAL MEMBERSHIP MEETING

**FEBURARY 23, 2023** 

**CALLTO ORDER: Chairman Dudley**

**INTRODUCTION OF SPEAKERS/GUESTS: Chairman Dudley** 

There were several new attendees (and some members that had not attended in a while) at this month's meeting that introduced themselves.

MINUTES OF LAST MEETING: Minutes of last meeting conducted January 26, 2023, were presented by Chairman Dudley. Copies of Minutes and Agenda are available on the sign-in table and were sent to members electronically by the Secretary. The minutes were approved by voice vote with no changes.

TREASURER'S REPORT: Treasurer John Mountcastle was not in attendance and Chairman Dudley provided a detailed report that as of January 25, 2023, there was a balance of \$118,844.72 and as of date of meeting there is balance of \$148,926.99. The income increase was due to combining the Vets for Vets account with the Veterans Council. There were \$3,000 worth of checks deposited last week. Chairman Dudley and David Shoar recently met with a group of financially stable men in Ponte Vedra and they have all pledged to help the Veterans Council in some financial way. Chairman Dudley left that meeting with a couple of checks totaling \$12,500.00. Congressman John Rutherford was also in attendance at this meeting and agreed to support the Veterans Council at the Congressional level. A copy of the Treasurer's Report with all expenses was provided. The Treasurer's Report was approved by voice vote with no changes.



### **SPEAKERS:**

DR. GEORGE CRESSMAN, HISTORIAN, CAMP BLANDING MILITARY MUSE-UM

Dr. Cressman spoke of highlighting some of the history of Camp Blanding. He expressed he would talk about how Camp Blanding came to be and then a little bit about what they are doing today. Camp Blanding was the successor to Camp Johnson and Camp Foster. That post was open in the early 20th century and in 1939 the Navy was looking for a new site and that portion that was Camp Foster became Naval Air Station Jacksonville. The Florida National Guard went looking for a new home and settled on an area adjacent to Kingsley Lake and purchased about 30,000 acres of land and began construction on what was to be a two regiment training facility. He then went into great detail on the history of Camp Blanding and what it is today. Dr. Cressman invited all to come and tour the Camp Blanding Military Museum. Dr. Cressman opened up the floor for questions and answers.

### JAMES BULLOCK, THE BATTLE OF FORT MOSE

Mr. Bullock spoke of the history of Fort Mose and its significance to the City of St. Augustine. The history of Fort Mose goes back over 263 years, the Battle at Fort Mose happened 35 years before the American Revolution. Mr. Bullock provided a timeline and a detailed talk of the history of Fort Mose. Mr. Bullock also provided a handout on the upcoming events to be held at Fort Mose. Mr. Bullock took questions and answers to finish his presentation.

### **COMMITTEE REPORTS:**

### VETERANS SERVICE OFFICE UPDATE, JOSEPH MCDERMOTT

Mr. McDermott discussed how the VA has now gone to an automation procession of claims. Mr. McDermott discussed how the automation process had already errored on a burial benefits claim so we will just have to see if this new processing of claims will be successful or not. Letters are going out to many

veterans from the VA that have served about the PAC ACT and what it entails. Toxic exposure was discussed and who and what may be covered by that through the PAC ACT. Mr. McDermott asked that if someone is in need of filing a claim, please don't try to do it yourself send them to the Veterans Service Office for assistance.

### VETERANS TREATMENT COURT, JOHN LESLIE

Mr. Leslie introduced himself, he is the mentor coordinator for the Veterans Treatment Court here is St. Johns and Putnam County. The Veterans Treatment Court has brought 122 veterans into the program in the last 6 years and 2 months. There have been 69 graduates and there are 35 currently in-flow. Court is held every 2 weeks and the next Court will be held on March 3rd beginning at 10:00am in Room 355. All are invited to attend and observe. There is a need for new mentors in the Treatment Court. There is also a need for those that already in the Court for treatment for community service hours and opportunities are needed to help the participates serve their 50 required hours.

Floor was then opened for questions and comments regarding the Veterans Treatment Court.

### **OLD/NEW BUSINESS:**

Chairman Dudley asked to bring a few things to the Council's attention. First, a Memorial Day Service is planned for May 29th at the St. Augustine National Cemetery at 10:00 am. Chairman invited everyone to attend for a large turnout and the new Brigadier General from the National Guard will be the speaker.

The second thing, was the effort that the Veterans Council is working on for hopefully building a homeless shelter in St. Johns County for our homeless veterans in the near future. The Council is working with the City, County, State and Federal Government to help with this process of obtaining a veterans' homeless shelter. There are hopes that within the next year to have a veterans'

homeless shelter, if not complete then at least started.

Chairman Dudley was contacted by the Veterans Service Office that we have a local veteran coming up on his 100th birthday on March 23, 2023. Chairman Dudley approached the County Administrator and Commission and asked that the Veteran be recognized at the next County Commission meeting and they agreed wholeheartedly to recognize him. On April 4th at the Commission Meeting, we will be recognizing the 100th birthday for Mr. John Patton. An invitation was extended to everyone to attend anhelp us honor Mr. Patton. It was agreed that any Veteran in the future reaching the 100th birthday will be recognized by St. Johns County.

Chairman Dudley has been appointed by the State House Speaker to the Council for the Florida Veterans Hall of Fame. Chairman Dudley accepted the appointment for a 2-year term.

Floor was opened to questions and answers or any new information that anyone may wish to share.

An unfortunate announcement was made that our Vice Chairman Ray Quinn is having to resign from the Council due to personal and health reasons. Chairman Dudley expressed what a valuable asset Vice Chairman Quinn has been to the Veterans Council since 2001. He has supported our Veterans in so many ways. He will be greatly missed at our meetings.

Next Veterans Council meeting will be held on Thursday, March 30th beginning at 7:00pm.

Meeting adjourned at 8:45 pm.



port personnel within the county, such as Nassau County Veterans Service officer and Veterans Treatment Court, will provide information and guidance.



### Woman flies to St. Augustine, surprises POW with bracelet she wore for him as a child

Peggy Cornacchio of Massachusetts surprised former POW Giles Norrington with this bracelet in his name that she wore as a child to honor him 40 years ago.



Giles Norrington and Peggy Cornacchio meet for the first time Saturday in St. Augustine. Cornacchio, who lives in Salem, Mass., flew to Jacksonville to give Norrington a POW-MIA bracelet she wore for him 40 years ago when he was a prisoner of war at the Hanoi Hilton.

This story ends in the exchange of a bracelet between two weeping adults who before Saturday night had never met.

It begins in 1971, when Peggy Cornacchio was 11, and her parents mailed off for a metal bracelet bearing the name of a U.S. prisoner of war. Many similar bracelets were worn during the intense years of the Vietnam War.

The name on the bracelet Peggy got was "LCDR Giles Norrington," a Navy pilot who had been shot down over North Vietnam on May 5, 1968.

Peggy didn't know Norrington or anything about his life. That didn't matter. On most school days for two years Peggy wore his name around her wrist. By wearing it she honored his service and sometimes, sitting in class at Nathaniel Bowditch School in Salem, Mass., the place where she grew up, she thought of Norrington and what happened to him.

Two years after she began wearing it, her parents read in the Boston Globe newspaper that Norrington had been released from captivity. Peggy felt relieved, but still wore the bracelet here and there for the other Americans left in Vietnam.

Then the war drew down, the bracelet was packed away, Peggy went to college, grew up and 40 years passed.

Last Christmas, rummaging through a box of forgotten keepsakes, Peggy came across the bracelet. Holding it for the first time in decades, she wondered.

What happened to Norrington? Where had he gone? Was he still alive?

She searched the Internet and found he was alive, living in Florida and scheduled to speak Saturday night in St. Augustine at the annual awards dinner for the Chase-Rescorla Scholarship. She felt like she needed to give him the bracelet.

"I thought he's got to be getting up there," she said. "If I don't do this now, it's not going to happen."

She bought a \$400 plane ticket and took some time off from work. Saturday morning she and a friend flew to Jacksonville from Boston.

She didn't tell Norrington she was coming.

#### **5 YEARS CONFINED**

An infamous place of torture and brutal confinement, the Hanoi Hilton was a prisoner of war camp in North Vietnam. Giles Norrington spent 1,775 days there.

He was from Ohio and joined the Marine Corps as an enlisted man out of high school in 1954. In 1965 he switched to the Navy. Three years later the plane he was piloting was shot down and he was captured.

He was tortured at first and then, he said, the hardships of isolation set in.

"The biggest enemy was boredom," he said. "What I mean by that is, we had no intellectual stimulation."

Norrington said the conversations he had with his fellow American POWs were "precious." They would tell each other the stories of their lives.

"When you were listening to those, it was a time away from your problems," he said.

The prisoners didn't know what would happen to them. They certainly had no idea people back home were wearing bracelets bearing their names.

On March 14, 1973, he was released.

When he got home he learned about the POW-MIA bracelets, which tens of thousands of Americans had begun wearing to remember the captured servicemen. Talking about what they meant to him recently, he got emotional saying that they represented the military men "who gave all."

He retired from the Navy in 1988, married and moved all across the country before he and his wife settled in Titusville, where they live today.

Over the years Norrington, 77, received more than 100 of the POW-MIA bracelets bearing his name.

Most arrived in the mail.

### **NOT FORGOTTEN**

When Cornacchio, 52, pulled the bracelet out of the bottom of that box on Christmas, it was broken. She took it to a jeweler in Salem who, after learning why she wanted it fixed, repaired it for free.



Cornacchio, the intact bracelet and her friend from Salem, Beth Ross, flew into the First Coast Saturday morning. They stayed at the home of Athena Tickner, a child-hood friend and Air Force veteran who lives in Jacksonville.

Getting ready to go to St. Augustine Saturday night, Cornacchio chose to not wear mascara. She was sure she was going to cry. And she did. "I can tell you that tears were streaming down my face and hers," Norrington said when describing their embrace.

He said when the stranger from Massachusetts handed him the bracelet at the dinner, he felt, "Joy and relief and just the kind of pleasure that you can't explain in words. I can't get over it."

Of all the bracelets he has received through the years, he called Cornacchio's the most important. She gave it to him two days after the 40th anniversary of his release from the Hanoi Hilton.

Cornacchio and her friend are flying back to Salem Tuesday. Cornacchio will be back to work Wednesday and when she goes she will carry a sense of relief.

"For me, it was so important that he knew there was a person out there who didn't forget about him," she said of Norrington.

He is back home in Titusville. Through the years, as he and his wife moved across the country, he donated a lot of the bracelets he received to military museums and historical societies. The one Cornacchio gave him is sitting on his kitchen table as he decides where to keep it.

He has no plans to give it away.

"There are some things in life that you just don't let go," he said. "And that's one of them."

ADDENDUM by Michael Rothfeld: A few years after this bracelet exchange local Vietnam veteran and historian, Terry Allan, was on a vacation in the New England area and came across two women standing in front of a Traveling Vietnam Wall. Terry offered to take their pictures and the women accepted his offer. The women thanked Terry and told him why they were at the Vietnam Wall, it was because Peggy Cornacchio had always worn the bracelet of ex POW Giles Norrington. Terry immediately realized what had just taken place. A one chance in a million encounter with the women he had met at the dinner in St. Augustine a few years back. They all embraced, a few tears were shed and they all remembered Giles Norrington, Capt. US Navy, retired and American Hero.

### **Fort Mose Historical Society**

Do You Know Your Fort Mose Historical Timeline?

- 1687 The first group of freedom seekers arrives in St. Augustine.
- 1693, King Charles II of Spain issued a royal proclamation granting liberty to all freedom seekers who would accept the Catholic religion. S
- 1738 Fort Mose is established on St. Augustine's northern border.



- 1740 British troops launch a month-long siege of St. Augustine. Allied Spanish and

Native forces and Fort Mose free Black militia win the Battle of Bloody Mose, although, during the battle, the fort is destroyed. St. Augustine remains under Spanish control.

- 1740 Fort Mose citizens move into town, living peaceably among local Spanish and Native residents.
- 1752 Fort Mose is rebuilt, close to the original site.
- 1763 England gains control of Spanish St. Augustine, upon conclusion of the Seven Years War. Most citizens of Fort Mose and St. Augustine evacuate to Cuba.

### From the Treasurer

This year, there are many changes to laws, only a few of which are more advantageous to the Veteran than in prior years.

### **Vote-By-Mail**

One of the little-known requirements is that Florida Voters' Vote-By-Mail requests expire at the end of the calendar year in which there is a general election which was a recent change in the law. In 2022, there was a general election, voting for Federal and State elected officials (remember those annoying ads?), so all requests from the 2022 elections have now expired.

If you prefer to Vote-By-Mail, now would be a good time to request mail ballots be sent to your St. Johns County residence, another address, or, if deployed, request an Overseas or Military Ballot, by going to https://www.votesjc.gov/vote-by-mail. Your Vote-By-Mail request will be valid for all local and state elections, and for the federal (general) elections in 2024.

You may choose an "All Elections Request" (valid through 2024) or request a mail ballot for a specific Individual Election (though I believe it makes life easier to submit an "All Elections Request"). If you have questions, or need assistance, please reach out to the Elections Office at (904) 823-2238.

### **Exempt Organization 2023 Filing Deadlines and Reminders**

**January 31, 2023**: Provide 1099-MISC and 1099-NEC to recipients, and file 1099-NEC with the IRS with 1096

February 28, 2023: File IRS copies of 1099-MISC together with 1096

May 1, 2023: File Florida Secretary of State Annual Report

May 15. 2023 (for calendar-year exempt organizations): File Form 990 family (990, 990-EZ or 990-N) electronically (this is the second year that only electronic filings are accepted). For exempt organizations with other fiscal years, due date is the fifteenth of the fifth month after the fiscal year -end.

Various dates (for charities, not Veterans' organizations recognized under §IRS 501(c)(19)), renew registration under the Florida Solicitation of Contributions Act with the Florida Department of Agriculture and Consumer Affairs. To check your renewal date, go to <u>Florida Charity Check</u>.

### Personal Federal Income Tax Deadline

The IRS's Free File program, available only at IRS.gov, allows taxpayers who made \$73,000 or less in 2022 to file their taxes electronically for free using brand-name software provided by commercial tax filing companies. Free File Fillable forms, a part of this effort, is available to any income level and provides free electronic forms that people fill out and file themselves also at no cost.

**Tuesday, April 18, 2023,** for most taxpayers, instead of April 15, because of the weekend and the District of Columbia's Emancipation Day holiday, which falls on Monday, April 17. The IRS will commence accepting 2022 individual federal income tax returns on January 23.

Navy Ship Named in Honor of One of Service's First Nurses

The USS Lenah Sutcliffe Higbee, a guided-missile destroyer, was recently launched by the United States Navy. The ship, christened in 2021, is named after one of the U.S. Navy's first ever nurses. Lenah Sutcliffe Higbee entered service in 1908 as part of the "Sacred Twenty," the U.S. Navy's first nurses. Within three years, she had gained leadership of the corps as the forerunner of today's Director of Nurse Corps.

Rear Admiral Cynthia Kuehner served as the representative of the Chief of Naval Operations at the ship's christening, where he spoke about what Higbee means to the Nurse Corps and Navy Medicine.

"As the 26th Director of the Navy Nurse Corps I recognize that I am here in no small part because of the vision, initiative and conspicuous achievements of this great warship's namesake," Kuehner said. "As the second Superintendent she led the Navy Nurse Corps with awe inspiring distinction. In this evening's ceremony we celebrate her legacy. We honor her service. And we ensure that the permanence of her indomitable spirit is enshrined and revered by all who behold her."

Higbee's care for thousands of casualties in World War I and during the so-called Spanish Flu epidemic that followed ultimately earned her a Navy Cross.

"Lenah Higbee understood in the context of World War I and the influenza pandemic of 1918 that nursing's presence on the front and in the fight is as essential to victory as any other element of modern warfare," Kuehner added. "With uncommon vision and valor Superintendent Higbee pursued credible standing for the all-female Navy Nurse Corps, fighting within the institution against overt discrimination and for the common basic features of military service including pay, rank, uniforms and even housing."

### The Star-Spangled Banner The story behind the song

If you have ever been to a U.S. sporting event—professional, college, or high school—you know the routine. People stand, some place right hands over their hearts, men take off their hats, soldiers salute, maybe fighter jets roar overhead. Then, six of the most recognizable musical notes in American culture are played, and the crowd belts out the first five words: "O say can you see ..."



Most people then mumble through the rest of the song. A recent poll reports that two-thirds of Americans do not know all the words to the first verse of their own national anthem. Perhaps if people know the amazing history of how this song came to be, they might find it easier to remember. Here is the story behind the "The Star-Spangled Banner."

### DidYou Know?

The commander of Fort McHenry, George Armistead, ordered "a flag so large that the British would have no difficulty seeing it from a distance." The giant 42-foot by 30-foot banner was sewn by Mary Pickersgill. This 15-star flag, the Star-Spangled Banner that inspired Francis Scott Key's poem, has been carefully preserved. Today it hangs in the National Museum of American History in Washington, D.C.

Francis Scott Key penned four verses to "The Star-Spangled Banner." Only the first verse is sung at most occasions. Occasionally, though, a performance will include the fourth verse, too.

Key—the man who described the U.S. as "the land of the free"—owned slaves, an ugly truth of the time. History is often weirder than fiction.

"The Star-Spangled Banner" has its critics. Some Americans complain that it celebrates war and should be reserved for military ceremonies. Others simply grumble that it is too hard to sing with a range that is out of reach for the average vocalist. Suggested replacements have included "America the Beautiful," "God Bless America," and "This Land is Your Land."

During World War II, Major League Baseball began the tradition of performing the "The Star-Spangled Banner" before games. Other sports soon followed suit.

The National Anthem Project promotes the learning of "The Star-Spangled Banner." Every year, it encourages schools to celebrate National Anthem Day on September 14th. For more information, check out their web page.

### A Baseball Player SPY

Born on Sunday, March 02, 1902 in New York, NY, Among the most scholarly professional athletes ever, Moe Berg was an alumnus of three universities, lawyer, mathematician, linguist, and poor hitter, eliciting the comment: "He can speak 12 languages but can't hit in any of them." His ability to handle young pitchers and his reputation as a bullpen mystic kept him in the majors, where his roommates won-



dered at his sacrosanct clutter of books and newspapers stacked in dozens of piles. He professed belief that his newspapers were "alive" and could "die" from being looked at by someone else. On occasion he braved snowstorms to purchase replacements for "deceased" newspapers.

Casey Stengel called him "the strangest man ever to play baseball" even before it was known he had served America as a spy. Some may have wondered why a third-string catcher like Berg went to Japan in the early 1930s with the likes of Ruth and Gehrig on an all-star traveling team. In fact, Berg was assigned to take espionage photos. During WWII, he became one of America's most important atomic spies, gathering vital information on top German scientists and even performing some missions that might have required assassination. He declined the Medal of Merit for his wartime service and never wrote his memoirs after being angered by an assigned co-author who confused him with "Moe" of the Three Stooges.

Berg fit the classic spy image: dark, heavy-featured, mysterious, sybaritic, courageous, and impeccably mannered. Women were attracted to the cultured, lifelong bachelor. When he was criticized for "wasting" his intellectual talent on the sport he loved, Berg replied: "I'd rather be a ballplayer than a justice on the U.S. Supreme Court."

"He [Moe Berg] bluffs his way up onto the roof of the hospital, the tallest building in Tokyo at the time. And from underneath his kimono he pulls out a movie camera. He proceeds to take a series of photos panning the whole setting before him, which includes the harbor, the industrial sections of Tokyo, possibly munitions factories and things like that. Then he puts the camera back under his kimono and leaves the hospital with these films," says Nicholas Dawidoff, a Berg biographer.

## From a few years ago but well worth revisiting

Terry Allan, esteemed Vietnam War Veteran speaks before 1,000's of St. Augustine, FL attendees at the world premier of Vietnam: Service, Sacrifice & Courage held November 7, 2010 at Flagler College. The documentary produced by media moguls Michael Rothfeld and Bill Dudley includes some of America's bravest men who served in Vietnam telling their personal stories. The event was also a chance for Congressmen, dignitaries and others to finally express Welcome Home to Vietnam Veterans.

Terry made an emotional presentation discussing the Differences Between Fairy Tales and War Stories. He vividly articulated how 50,000,000 men who reportedly served in combat during the Vietnam era tell War stories today about their brave deeds. Mr. Allan pointed out that only 5,000,000 men actually served in Vietnam, but who's counting when you're dealing with some Fairy Tales.



# **Tax Tips for Survivors**



The Primary Next of Kin is responsible for the deceased Sailor's last tax return. Know your rights and benefits as a Surviving taxpayer.



#### What is my tax filing status as a Survivor?

di di

If you were married at the time your spouse died, you may still file a joint return for the year of your service member's death. This gets you the best tax rate (and the largest standard deduction, if you do not itemize).

Survivors filing a joint return may claim the full exemption amount for the decedent regardless of the date during the year when the death occurred.

fears 2-3

If you have one or more children, you may file as a "qualifying widow or widower" for the next two tax years, so long as you do not remarry. This status lets you use joint-return tax rates.

Year 4

Starting in year four, if you have dependent children, you may file your tax return as a "head-of-household." Tax rates are less favorable than those for joint returns but better than the rates for single taxpayers.

# When will I get my service member's W-2?

The Defense Finance and Accounting Service (DFAS) issues a W-2 for deceased service members who had income during the tax year. The W-2 will be sent to the address on record for the service member after January 1 of the year following the member's death.

# How do I replace a lost W-2?

If the address on record is incorrect and the W-2 cannot be delivered, or if the document is lost, you can request a reprint by calling DFAS (Cleveland) at 1-888-332-7411. Phone tree prompts are 4, 2, 4, then select the branch of service, then 1 and 1.

# Are there any special tax provisions for Survivors?

Yes. In certain cases, widows and widowers get a tax break on individual retirement accounts (IRAs) inherited from a spouse and on proceeds from the sale of a home.

If the service member died as a result of active service in a combat zone (according to the definitions provided in the benefit laws), the member's Federal income tax liability may be forgiven. Any taxes paid for the year of death will be refunded, and any tax liability at the date of death will be forgiven.

Parents of an unmarried deceased service member must file a tax return on behalf of their child for the year of the death. # How the PACT Act is Already Helping Veterans

# Veterans are applying for benefits and VA is expediting delivery

The PACT Act is a historic new law that will help VA provide health care and benefits to millions of toxic-exposed Veterans and their survivors. Since President Biden signed the PACT Act into law on August 10, VA has been hard at work implementing this landmark bipartisan legislation—and Veterans have already begun to apply for the benefits they've earned and deserve.

Here's an update on what's happened since August 10th:

Veterans are applying for the PACT Act benefits they deserve

The day after the PACT Act was signed into law (August 11), Veterans set an all-time record for filing online disability compensation claims. Since the PACT Act was signed, Veterans have filed more than 200,000 total claims—an increase of more than 21% over the same period last year. And to date, VA has already received more than 70,000 PACT Act-related claims from Veterans since August 10.

Thousands of Veterans participated in toxic exposure screening pilot

As a part of the PACT Act, VA will begin providing 5-minute toxic exposure screenings to all Veterans enrolled in VA health care. On September 6, VA began a pilot of this program—screening 13,380 Veterans across 12 medical centers over a 2-week period, and finding a 37.4% concern of exposure among those Veterans. These results will help VA make toxic exposure screenings available to all Veterans in early November, and more importantly, make sure that VA provides all toxic-exposed Veterans with the care they need and the benefits they deserve.

VA expedited the timeline to deliver benefits to Veterans as soon as possible

Instead of phasing-in conditions over the coming years (as outlined in the legislation), the Biden Administration decided to make all conditions in the PACT Act presumptive for benefits as of August 10, the day the bill was signed into law. We will begin processing these benefits on the earliest date possible, which is January 1.

VA will expand health care eligibility in October

On October 1, VA will expand and extend eligibility for VA health care for certain Veterans of the Gulf Wars and post-9/11 era. This expansion will increase health care eligibility for hundreds of thousands of toxic-exposed Veterans. Additionally, VA has already expanded health care eligibility for certain Veterans of the Vietnam War. More detailed information about this expansion can be found on VA.gov/PACT.

Meeting Veterans where they are

Within minutes of the PACT Act passing the Senate, VA launched VA.gov/PACT—a one-stop-shop website where Veterans and their families can learn about the PACT Act and apply for health care or benefits. This website, which is available in English and Spanish, has garnered nearly 2.5 million views to date.

#### PROPERTY TAX BENEFITS FOR ACTIVE DUTY MILITARY AND VETERANS

Certain property tax benefits are available to members of the Armed Forces.

Property Tax Oversight

#### Filing and Keeping Your Homestead Exemption

When a person serving in the Armed Forces owns and uses property as a homestead, the servicemember may rent the homestead property without abandoning the claim to the homestead exemption (see section 196.061, Florida Statutes).

A servicemember's next of kin or any other person who has written authorization may file a homestead exemption claim on behalf of a servicemember who cannot file in person because of a service obligation (see s. 196.071, F.S.).

# Property Tax Exemptions and Discounts

Eligibility for property tax exemptions depends on satisfying certain requirements.

Information is available from the property appraiser's office in the county where the veteran or surviving spouse owns a homestead or other property.

 An ex-servicemember who was honorably discharged, is a resident of Florida, and who is disabled to a degree of 10% or more because of misfortune or while serving during wartime may be entitled to a \$5,000 reduction in his or her property's assessed value. This exemption is

not limited to homestead property. Under certain circumstances, the veteran's surviving spouse may be entitled to carry over the exemption. See Form <u>DR-501</u>. (see s. 196.24, F.S.)

- Veterans who are Florida residents and were honorably discharged with a service-related total and permanent disability may be eligible for a total exemption from ad valorem taxes on property they own and use as their homesteads. A similar exemption is available to disabled veterans confined to wheelchairs. Under certain circumstances, the veteran's surviving spouse may be entitled to carry over the exemption. See Form <u>DR-501</u>. (see ss. 196.081 and 196.091, F.S.)
- If they meet certain requirements, veterans 65 or older who are partially or totally permanently disabled may receive a discount on the assessed value of property that they own and use as homesteads. This discount carries over to the veteran's surviving spouse if the spouse holds the legal or beneficial title to the homestead, permanently resides there and has not remarried. The discount is a percentage equal to the percentage of the veteran's permanent, serviceconnected disability as determined by the United States Department of Veteran's Affairs. See Form <u>DR-501</u>. (see s. 196.082, F.S.)

Eligible veterans who want to apply for these exemptions may apply before they receive the necessary documentation from the United States government or the United States Department of

Veterans Affairs or its predecessor. After the property appraiser receives the documentation, the exemption will be effective as of the date of the original application. Please see the How to Apply for a Refund brochure for information about refunds.

 A member or former member of any branch of the United States military or military reserves, the United States Coast Guard or its reserves, or the Florida National Guard may receive an exemption if he or she was deployed

during the previous calendar year outside the continental United States, Alaska, and Hawaii in support of a designated operation (the Florida Legislature designates operations for this exemption). The percent of the taxable value that is exempt for the current year corresponds to the percent of time during the previous year when the service member was deployed on a designated operation. See <a href="Form DR-501M">Form DR-501M</a>. (see s. 196.173, F.S.)

You should file all required forms and applications for these exemptions with your county property appraiser. If the property appraiser denies your application, you may file a petition with the county's value adjustment board. For more information, see Petitions to the Value Adjustment Board.



# **VA SURVIVOR BENEFITS & THE PACT ACT**

ESGR4U

You may be eligible for VA benefits and services after your loved one has passed.



## The PACT Act makes it easier for many survivors to receive Dependency and Indemnity Compensation (DIC).

VA will be contacting survivors who were previously denied DIC benefits and may be newly eligible under the PACT Act. You do not need to wait for VA to contact you to submit a claim.

#### How to Apply for DIC and/or Accrued Benefits

Surviving family members may apply for these benefits using the appropriate VA form on va.gov/family-member-benefits.



#### Dependency and Indemnity Compensation

Monthly payment for the eligible surviving spouse, dependent children or parent(s) of the Veteran or service member IF Veteran or service member died in the line of duty or due to a service-related injury or illness.



#### **Accrued Benefits**

A one-time payment to a surviving spouse, dependent child(ren) or dependent parent(s) of a deceased Veteran based on relationship when the record shows additional benefits (such as VA compensation or pension) due to the Veteran prior to passing.

#### **Additional Survivor Benefits Available:**



#### **Burials and Burial Allowance**

Burial benefits available include a gravesite in any of our National cemeteries with available space, opening and closing of the grave, perpetual care, a government headstone, marker, or medallion, a burial flag, and a Presidential Memorial Certificate, at no cost. Some survivors may also be eligible for a plot allowance, transportation allowance, and burial allowances based on the service connected disability status of the deceased Veteran.



#### **Final Monthly Payment**

If a Veteran who is receiving VA compensation or pension benefits passes away, their last month of benefits can be paid to their surviving spouse.



#### **Home Loan Guaranty**

Certificate of Eligibility is available for surviving spouses receiving DIC.



#### **Education and Training**

Chapter 35 benefits and Fry Scholarship are the two main GI Bill programs offering educational assistance to survivors and dependents of Veterans who died in the line of duty or as a result of service-related disabilities.





#### Are You eligible to file for benefits based on Presumptive Exposure?

Were you exposed to hazardous materials while serving in the military, such as from Agent Orange or burn pits? Did you serve in Vietnam, Thailand or Southwest Asia? If so, you may be eligible to file for service-connected benefits based on presumptive exposure.

Over the course of the last six months, VA has begun processing service-connected disability claims for six new presumptive conditions related to exposure to hazardous materials.

In May 2021, VA started implementing provisions of the William M. Thornberry National Defense Authorization Act for Fiscal Year 2021 (NDAA), adding bladder cancer, hypothyroidism and Parkinsonism to the list of medical conditions presumptively associated with exposure to Agent Orange. A few months later, VA added asthma, rhinitis and sinusitis (to include rhinosinusitis) on a presumptive basis based on particulate matter exposures during military service in Southwest Asia and certain other areas.

Any Veteran who was previously denied service-connection for any of these six conditions but had symptoms manifest within 10 years of military service would need to file another claim. Be sure to use VA Form 20-0995, "Decision Review Request: Supplemental Claim" when filing. The claim form should include the name of the medical condition and also specify that the medical condition is being claimed due to in-service exposure to environmental hazards.

VA is committed to assisting Veterans who may have been exposed to hazardous materials during their military service.

Be sure to stay plugged in to www.va.gov for the most recent developments around environmental hazards; VA is constantly conducting research and surveillance, as well as reviewing scientific literature for conditions that may be related to exposure during military service.

If you feel you have a chronic condition attributed to an in-service exposure, we highly encourage you




