Fellow Veterans, I trust everyone had a great Holiday and was able to stay well and healthy during this time. We are now into our new year with lots of challenges for helping our veterans during 2022. Affordable housing continues to be a major challenge and one that the Veterans Council is focused on this year. Last Thurs the Veterans Council met with the Care Connect Team from Flagler Health as well as members from St. Johns Housing Partnership, SJC Project Management and members of the Veterans Service Office. Lots of discussion concerning new housing startups in the affordable range for veterans that will be coming on line in the Springmid summer timeframe. We plan to meet on a regular basis to continue pursuing other housing opportunities that are in the affordable range for

veterans.

This past Friday, 18 January the Veterans Treatment Court celebrated its 5th anniversary. It was a very special celebration honoring all those who had graduated from the program, those still enrolled in the program and a special graduation for 4 veterans who graduated during the ceremony. Many of the original team members were in attendance as were many of our local law enforcement, County Commissioners, County Administration, local judges, and state and federal elected officials. We were honored to have retired Lt.Gen. Michael Linnington, CEO, Wounded Warrior Project as our guest speaker. This program has been a huge success by any standard of measurement boasting a recidivism of less than 4 % and a graduation of 53 veterans. That's a huge return on investment. There are currently 26 veterans enrolled in the program.

Request Military Records

New! The National Personnel Records Center is closed due to the COVID-19 pandemic. They will continue servicing emergency requests associated with medical treatments, burials, and homeless veterans trying to gain admittance to a homeless shelter. Please refrain from submitting non-emergency requests such as replacement medals, administrative corrections, or records research until they return to pre-COVID staffing levels.

Most federal, state and local veterans' benefits require proof of military service through an official discharge document, often called a DD-214 or one of its predecessors. You may request a free copy of your military service record through the National Archives at http://www.archives.gov/veterans/.

What do they hold?

Official Military Personnel Folders (OMPF) including the Service Treatment Record (includes outpatient, dental and mental health treatment).

Clinical (hospital inpatient) records created for military personnel while on active duty.

Medical treatment records for military retirees, dependents, and others created at military medical treatment facilities (includes inpatient, outpatient, dental, and mental health treatment).

What records are there?

U.S. Air Force 1947-2004

Records from 1947-1963 (Hubbard –Z) were impacted by 1973 fire

U.S. Army 1912-2002

Records from 1912-1959 were impacted by 1973 fire

U.S. Coast Guard 1898-2008

U.S. Marine Corps 1905-1998

U.S. Navy 1886-1994

Records Not at National Personnel Records Center (NPRC):

Records of soldiers currently on active duty and records of veterans who have separated but still have reserve status remain with military services.

Pay records are held by Defense Finance and Accounting Service.

GENERAL MEMBERSHIP MEETING

16 DECEMBER 2021

WELCOME AND OPENING REMARKS: Chairman Dudley

APPROVAL OF PREVIOUS MEETING MINUTES:

Chairman Dudley offered that the minutes had been published and distributed to general membership and asked if there were additions or deletions required.

Hearing no change, a vote of members present was unanimous in acceptance.

TREASURERS REPORT:

Treasurer John Mountcastle presented a most comprehensive four page finance report. He stated that the current balance for the council is \$65,630.50. He stated that approximately fifty-percent of this balance is restricted to specific programs. Most expenses reported on this report were from supporting the Veterans Day Program. It is well to note that the council received a check for \$7,750 donated by the PGA Tours (Story Tellers). Copies of the treasurers report were available to all members present. After a detailed explanation of the report a unanimous vote to approve was received.

SPEAKERS OF THE EVENING:

HorsePlay Therapy Center

The council welcomed Vicky Carregal of HorsePlay Therapy Center. Vicky explained that as of Veterans Day 2021 the therapy offered at HorsePlay includes therapy for veterans. Conveniently located near I-95 and State Road 207 the facility offers a calm relaxed atmosphere for those truly in need. A team of knowledgeable therapist offer Equine Assisted Therapy (EAT) for veterans suffering from PTSD and wounded warriors. Therapies include movement of a horse, horsemanship ac-



tivities, horse human interaction and mental therapy in an open air environment. Our council was asked to assist in making know this facility as there are veterans in our area that would truly prosper by participating.

USS Orleck Museum

Daniel Bean (Presenter)

The council was provided an update on the approval, condition and arrival plans for the USS Orleck to become a grand fixture of the Jacksonville skyline. The ship was recently moved to dry dock and is undergoing cleaning, repair and painting. Part of the dry dock procedure is to ensure the ship's worthiness. It currently located at Port Arthur. The ship will be the site of many community activities.

COMMITTEE REPORTS:

CSM Joe McDermott, Veterans Service Officer

Joe announced that funds have been received for a new employee. This person will be dedicated to the Housing Program for homeless veterans.

Of particular concern at present is the time lag for veterans to receive their decision on outstanding claims. There was a huge delay in mailing claim decisions recently and currently that caused veterans that did not agree with the decision to miss the appeal suspense date. Fortunately, there has been a decision made to extend the appeal window in cases where the veteran was victimized.

John Leslie, Veterans Court Chair

John announced the current number of participants and stated that Friday 17 December 2021 is the next court date. All veterans are invited to attend. Location is the Watson Judicial Center. Allow time for security check.

Ray Quinn, Wreaths Across America Co-Chair

Ray announced the program for 2021 is on track for success. The off load and placement of the wreaths is scheduled for 9:00 a.m. Saturday 18 December 2021. Many local organizations are on our list to assist and hopefully our membership will be present as well. Financially we were successful in attaining our goal and have a really good carry over for next year. I will be offering a final report at our January 2022 meeting. BG (Ret) Michal Fleming, Florida Fire Watch

General Fleming explained the Watch Stander program and the training requirements. He encour

aged the council to get involved by going online and taking the Watch Stander course. By doing so you will have a personal and meaningful part in reducing the terrible suicide rate among our veterans.

Steve Spickelmeir, Jacksonville National Cemetery Support Committee

Steve provided an overview of the plan for Wreaths Across America at Jacksonville National. The challenge there is 20,000 grave sites.

Steve also announced the new road is now open to the Jacksonville National Cemetery. No longer will visitors have to drive the eight mile rural route. The cemetery may be entered after exiting I-95 at the Pecan Park exit and following the signs. The road has been named in honor of Gold Star Families.

Steve also provided an update on the Missing In America program. In February the program will lay to rest unclaimed veterans and spouses at the Cape Canaveral National Cemetery. This will represent the 28th service conducted providing final honors for those unclaimed.

Bill Dudley, Council Chairman

Bill presented a report on our highly successful Veterans Day Program conducted 11 November 2021 at Anastasia Baptist Church. Bill had nothing but praise for the team that put the event together and brought it to a memorable occasion. He stated he is receiving comments from all over the community.

Bill announced that the Veterans Court has now been in existence for five years. He commended John Leslie for his tireless work in establishing and contributing to the court's success.

Bill announced the formation of the Veterans Support Committee. It became evident that since we gain our funds almost primarily from grant sources we need more oversight and input from the council on selection of grant sources. He announced that the following have agreed to serve on the committee:

During Calendar Year 2021, the Veterans' Council of St. Johns County, Inc. received more than \$40,500 in cash donations to support our missions.

This year, the Veterans' Council also created a semi-permanent endowment in the name of our Chairman, William Dudley; \$1,500 was donated specifically for this purpose. Grants would be made from income

derived by this endowment; at the discretion of trustees, grants may also be made from principal invested.

In addition to the above cash transactions, the Veterans' Council received donated goods and services valued at more than \$4,700, in furnishings reserved to assist deserving Veterans who will move into Veterans -dedicated housing provided by the St. Johns Housing Partnership this year.

During 2021, the Veterans' Council expended approximately \$39,500 in support of the missions of the Veterans' Council; summarized by program expenses:

Assistance to Veterans in Need aided more than ten families with temporary lodging, replacement of HVAC, car repairs, funeral expenses and emergency assistance. None of these were included in the Veterans' Treatment Court, which had more than thirty participants who received assistance with court fees, gas and food cards, lodging assistance, vehicle repairs; at year-end, fourteen deserving participants identified by the Court each received \$200 checks as holiday gifts in recognition of their rehabilitation efforts.

Public Charities are evaluated by their ability to focus upon their missions, manage their expenses and be good stewards of the assets entrusted to them. With more than 80% of gross receipts expended on programs, less than 6% spent on overhead, and less than 1% spent on fund-raising, the Veterans' Council compares quite favorably.

Guidestar reports the Veterans' Council has a gold rating.

Michael Pullium, Vietnam Veteran


A few days ago the veterans community as well as the St Augustine community lost a larger than life contributor, Vietnam veteran Michael Pullium.

I first met Michael when he asked me in 2008 to join his committee that was hosting the Chase/Rescorla Annual Dinner and scholarship fundraiser. Michael was the Chairman and driving force behind the successful planning for the event.

What follows is an article about the Chase/Rescorla Scholarship Dinner by Peter Guinta, also a Vietnam veteran and writer for the St. Augustine Record.

Moorman, a Palm Coast resident and former city commissioner, said he wants young people to cultivate their courage and think about who their friends are.

"Young people don't listen to adults that much, but they sure imitate them," Moorman said. "They need role models. To me, everyone is a role model, whether they're a good one or a bad one."

The scholarship fund was formed to recognize the sacrifice of two 1st Cavalry Division, 7th Cavalry Regiment soldiers.

Pfc. Leo C. Chase Jr., a St. Augustine native and son of a prominent local family, was killed at his post Nov. 15, 1965, on the second day of the three-day Battle of the Ia Drang Valley in South Vietnam.

The dinner honors both heroes, but also all those who have not returned from battle and all veterans.

Since the first dinner on March 31, 2007, the fund has awarded more than \$30,000 to local students. Major donors include the Allied Veterans of the World, the Scheidel Foundation, American Legion and AMVETS.

Today we remember not officially one of our own, but a Vietnam MIA*POW that we've adopted.

On January 7, 1970, LtCdr. Michael Hoff was launched from the USS Coral Sea as the pilot of a Sidewinder A7A Corsair aircraft. His mission was to perform armed reconnaissance over Laos.



The weather in the area was clear and visibility was about 10 miles. Hoff's aircraft was completing a strafing run near the city of Sepone when Commander Hoff radioed that he had a fire warning light and was going to have to bail out. The flight leader could not see the aircraft at that time. The leader did sight the aircraft just as it impacted in an area which was flat with dense vegetation and high trees.

The pilot of another aircraft reported sighting Hoff's aircraft below him, when it was approximately 2,000 feet above the ground. The aircraft at that time commenced a roll and, prior to reaching an inverted position, a flash was observed which was initially thought to be the ejection seat leaving the aircraft. Immediately afterwards, the aircraft impacted and exploded. No parachute was seen, nor were emergency transmissions received.

During ensuing search operations, aircraft reported that they received heavy enemy automatic weapons fire. Two aircraft were able to make repeated low passes in the crash area looking for a parachute or survivor, but the results were negative.

Commander Hoff's wife was also the reason that we have the POW*MIA flag we do today. In 1970, Mrs. Michael Hoff, an MIA wife and member of the National League of POW/MIA Families, recognized the need for a symbol of our POW/MIAs. Prompted by an article in the Jacksonville, Florida, Times-Union, Mrs. Hoff contacted Norman Rivkees, Vice President of Annin & Company, which had made a banner for the newest member of the United Nations, the People's Republic of China (PRC), as part of their policy to provide flags of all United Nations member states. Mrs. Hoff found Mr. Rivkees very sympathetic to the POW/MIA issue. He and an Annin advertising agency employee, Newt Heisley, designed a flag to represent our missing men.

Following approval by the League's Board of Directors at a meeting held January 22-23, 1972, POW/MIA flags were manufactured for distribution. Wanting the widest possible dissemination and use of this symbol to advocate for improved treatment for and answers on American POW/MIAs, no trade mark or copyright was sought. As a result, widespread use of the League's POW/MIA flag is not restricted legally. The large volume of commercial production and sales now required to meet demands of federal and state laws does not benefit the League financially, though Annin & Company did contribute a modest amount on one occasion.

On March 9, 1989, an official League flag – flown over the White House on National POW/MIA Recognition Day 1988 – was installed in the US Capitol Rotunda as a result of legislation passed overwhelmingly during the 100th Congress. In a demonstration of bipartisan Congressional support, the leadership of both Houses hosted the installation ceremony, at which League Executive Director Ann Mills-Griffiths delivered remarks representing the POW/MIA families

New exhibit brings to life stories of World War II soldiers from St. Johns County

When Pearl Harbor was attacked on Dec. 7, 1941, millions of Americans from communities across the nation soon enlisted or were drafted into the ensuing war.

Many of those soldiers were from St. Johns County, and local historian Susan Parker recently brought to life some of their stories in a new virtual exhibit sponsored by the St. Johns



County Clerk of the Circuit Court and Comptroller.

On the 80th anniversary of the attack on Pearl Harbor, Parker said she and county officials wanted to commemorate the service of these individuals. The online exhibit, simply titled "The Greatest Generation," is based on discharge papers from World War II veterans returning to St. Johns County.

The documents were duplicate copies of the soldiers' originals and stored at the Clerk of the County's office, mostly in case vets needed to produce them as proof for medical, educational or other benefits following the war.

In digging through hundreds of papers, Parker chose to focus on just a handful to highlight, as she said, "the range of types of people who went and the types of service they did and where, because it really was such a global war."

The expertise of Parker, who formerly headed up the St. Augustine Historical Society, is Spanish Colonial history but she used her research skills to hone in recently on this chapter of local history.

"These are not the people whose names are on monuments; these are the ones who survived and returned home," Parker said.

In digging through hundreds of papers, Parker chose to focus on just a handful to highlight, as she said, "the range of types of people who went and the types of service they did and where, because it really was such a global war."

The expertise of Parker, who formerly headed up the St. Augustine Historical Society, is Spanish Colonial history but she used her research skills to hone in recently on this chapter of local history.

"These are not the people whose names are on monuments; these are the ones who survived and returned home," Parker said.

Their range of backgrounds surprised Parker the most. Among them: Upon return, their transition to civilian life had to have been challenging, especially with women at that point filling many jobs while men were overseas.

"There's a lot written about men trying to find jobs," added Parker.

Parker's research did not extend to learning what happened to the World War II soldiers she profiled in her exhibit; she imagines many of them may be gone now. But she hopes families connect with their stories and learn more.

Parker also hopes that the exhibit helps to make more real the stories of everyday men and women who were plucked from their local communities to serve in engagements across the world and how that experience impacted them.

"Going to war pulled people out of small rural areas and they were suddenly experiencing the rest of the world," said Parker. "I often wonder what difference it made in their lives, getting on a ship and going across the ocean to a different place with different people."

The Clerk's Office encourages St. Johns County's 20,000-plus veterans to record their discharge documents securely and free of charge.

By filing a discharge document — these days called a DD Form 214 — veterans can ensure future easy access. Original DD 214s can be filed at no cost at the county's Recording Department, located in the Richard O. Watson Judiciary Complex, 4010 Lewis Speedway, St. Augustine. The document will be digitally recorded on site and returned immediately.

JACKSONVILLE, Fla. – A highly decorated retired Navy destroyer will

soon become a downtown attraction on the St. Johns River.

Daniel Bean, president of the Jacksonville Historic Naval Ship Association, signed for ownership of the USS Orleck on Tuesday afternoon.

"As you all know the city of Jacksonville is the third largest navy installation in our country and like the other 35 cities with war ships on display



it is time for Jacksonville to have a symbol of the United States Navy and what the United States Navy has meant to Jacksonville and its development," Bean said.

The JHNSA has been working with the city to make the USS Orleck a Jacksonville Naval Museum at the Shipyards. They now hope to have the top tier open to the public in 30 days.

At a private ceremony Tuesday at Manifest Distillery, the Jacksonville Naval Museum took official ownership of the USS Orleck Museum Ship.

"This will be a wonderful attraction for the city, this will be a wonderful way to honor all of the veterans in Northeast Florida," Bruce Fouraker, JHNSA board member, said. "Jacksonville has over 250,000 military veterans that live in the area and this is just a wonderful thing to have."

The USS Orleck is in dry dock, in Texas, where it has undergone a bow to stern inspection. A sign already placed in the Jacksonville shipyards says "coming soon — Future home of the USS Orleck Museum Ship."

But getting to this point has come with challenges.

The cost to bring the Orleck to Jacksonville has gone up significantly from the last estimate in March 2020 of \$1.3 million and \$56,000 for paint.

The project is now expected to have a price tag of \$1.8 million due to \$250,000 of new repairs needed because of Hurricane Laura, cost increases include money for materials, fuel and labor -- plus \$65,000 for paint.

In September, News4JAX spoke with Justin Weakland, a member of the Jacksonville Naval Museum, who said getting this ship to Jacksonville would create an instant tourist attraction because we have Naval stations here, veterans and history lovers who would want to see this ship.

The group has released some examples of what the museum could look like once it's complete and is collecting donations to help offset the cost.

Next to the ship, there are plans for a ticket office, gift shop and a park that could include Naval aircraft on display.

The Jacksonville Naval Museum will feature the "US Navy Cold War Experience," which is represented by the ex-USS Orleck.

It is named after Lt. Joseph Orleck. The ship was called the "Top Gun" of Vietnam, fired 11,000+ rounds earning the nickname "Grey Ghost of the Vietnam Coast" and netting an astonishing 14 battle stars throughout the war. It received dozens of awards for military service.

It was the most decorated post World War II ship ever built and supporters said that is reason enough to save it.

The Orleck embodies the Korean War, Vietnam War, and Cold War periods in US Navy history, having served in all three.

To fund the only U.S. Naval warship museum in Florida, the group has \$2.5 million: \$1 million from the state of Florida and another \$1.5 million from loans and creditors.

It will support veterans as a local resource and networking center.

BRING HOMETHE BOLD ONE – USS JACKSONVILLE RETIRES

USS Jacksonville, "A Steely-Eyed Killer of the Deep" Retires. November 25, 2021

Local group on The Liberty Coast hopes to acquire the sail of the former submarine JACKSONVILLE and put it on display in Downtown Jacksonville.



Of all the commissioned warships and vessels that have served in the US Navy since its inception in 1775 there has been only one ship named after Jacksonville, Florida, and it represented its namesake with honor.

That special ship is a nuclear powered, Los Angeles (688) Class submarine, the USS Jacksonville (SSN 699). The ship, errr, "boat" as submarines are called, was commissioned on May 16, 1981 and made its first port visit to its namesake city in June 1981 where she and her crew received a warm welcome from the city and its residents.

After 40 years of service defending this great country and deploying around the globe, the "Bold One" was recently decommissioned in November 2021. She is in Bremerton, Washington being prepared for her after-life as dismantling a nuclear anything is an extensive process, as one may expect.

During her four decades of distinguished service, the SSN 699 made 15 overseas deployments, circumnavigated the world twice (mostly submerged), served as a duty station for seven future admirals and one future master chief petty officer of the navy (MCPON), received numerous awards including three battle efficiency awards, underwent underwater shock testing representing the entire 688 Class submarines, resided at three homeports (Groton CT, Norfolk, VA and Pearl Harbor, HI) and served as home away from for a few thousand proud sailors

USS Jacksonville (SSN 699), AKA the "BOLD ONE" served her nation for 40 years.

"There are two special crews in the life of a submarine: the commissioning crew and the decommissioning crew," said Cmdr. James Wiest, commanding officer of Jacksonville. "We as the decommissioning crew were tasked with gracefully, nobly, and re-



spectfully retiring this warship and honoring the 1,700 plus Sailors who served in her over the last 40 years."


"As we close the chapter of this magnificent warship, it is important to remember that without the crew, a Naval vessel is just a hulk of steel," said Wiest. "It is the crews that served aboard her that brought her to life, and kept her alive to do her duty. The rules of the Silent Service prevent specific discussions of her accomplishments, and that is as it should be. Jacksonville was a steely-eyed killer of the deep because of the men who served aboard her. And that, my fellow Americans, is how she should be remembered."

While the USS Jacksonville's distinguished career is ending, her legacy is not. The effort is underway to retire the entire sail structure of the USS Jacksonville in its namesake city to honor its service and represent yet another example of The Liberty Coast's rich naval and military heritage. 


- 1) how he always signed his name, "For His Honor, Gary Beikirch"

Year End Reminders for Exempt Organizations from Veterans Council Treasurer, John Mountcastle

Filing Reminder

Exempt organizations should provide donors of monetary gifts of \$250 or more with a <u>written acknowledgement</u> from the charitable organization, so the donor may be able to deduct their donation from their federal taxable income. The donor must get the acknowledgement by the earlier of:

- 1. The date the donor files the original return for the year the contribution is made, or
- 2. The due date, including extensions, for filing their return.

Non-cash contributions must not only meet the above timeline, but also include additional required substantiation.

All payers of \$600 or more in the course of their business (including charities) must prepare Forms 1099-NEC and/or 1099-MISC, submitting them to the IRS and to the payee by January 31, 2022. If the organization prepares 250 or more forms filed with the IRS (can be of any type, such as W-2s or 941s for employers, 1099s, etc.), all forms must now be filed electronically.

New This Year

Virtually all exempt organizations (i.e., Public Charities, Veterans' organizations, etc.), must file their information reporting for tax (fiscal) years ending after July 31, 2021 electronically. For organizations using the calendar-year ending Dec. 31, 2021, the filing deadline for forms in the 990 series is May 16, 2022.

Any exempt organization (other than a private foundation) that normally has annual gross receipts of \$50,000 or less and therefore is eligible to file an <u>annual electronic notice</u> Form 990-N instead of an annual information return), although the organization may elect to prepare a full Form 990 (or 990-EZ) return for other reporting purposes. Form 990-N is an online form with only a few questions and should not require the services of a tax professional.

Exempt organizations having gross receipts of \$200,000 or more, or total assets of \$500,000 or more must file Form 990 and related schedules. Exempt Organizations with gross receipts from \$50,000 to less than \$200,000, and with total assets less than \$500,000, may elect to prepare Form 990-EZ.

Private foundations must file Form 990-PF.

If the exempt organization does not use a tax professional to prepare and electronically file the appropriate returns, the organization's qualified reporting person must use appropriate tax software which is capable of submitting the organization's returns electronically.

The IRS website lists approved <u>vendors of qualifying software</u>; most have significant annual costs to obtain a license to use the software. There is at least one vendor, <u>Form 990 Online</u>, offering free use of their online software to prepare and electronically file Form 990-EZ ONLY IF the exempt organization's gross receipts are less than \$100,000. I have not had a chance to review their website and accordingly cannot endorse this vendor. My research is not all-inclusive and there may be other vendors offering free use of their software.

The Mothballed Fleet at Green Cove Springs

On the 8th of May, 1945, just eleven months and two days after the allied invasion of Nazi-occupied France (D -Day), victory was declared as the Nazi war machine fell to defeat. Hitler's forces had fallen to the advance of the Allies who came from the north, south, east, and west in a coordinated effort to crush the greatest threat to humanity that the world had ever seen. May 8th is commonly known as VE-Day, or Victory in Europe Day, though the Russians celebrate May 9th (due to time zone differences). The surrender of all German forces came one day prior, on May 7th, and just one week after Adolf Hitler committed suicide. Victory over Japan (V-J Day) soon followed on August 15th, 1945, when Emperor Hirohito of Japan announced Japan's official surrender. The official U.S. V-J Day would not be observed until September 2, 1945, when Japan signed the official surrender document aboard the battleship U.S.S. Missouri. All over the free world, citizens gathered in the streets to celebrate the end of the horror that was World War II. It is estimates that 70 to 85 million people perished in the world-wide struggle.

Over the next few years, life would slowly begin to return to normal for most Americans who were not faced with the daunting task of rebuilding whole countries that were destroyed by the war. The massive industrial machine that won the war by supplying armaments, planes, and ships slowly wound down and either refitted to produce peace-time products or went out of business entirely. This was the case for many of the shipyards here in Florida. With the return of hundreds of ships back home, the Navy needed installations to process them. There were many such locations established along the eastern seaboard, and one of them was Green Cove Springs, Florida.

Green Cove Springs already housed the Naval Air Station at Lee Field. It was here that the Navy built 13 piers, each one 150 feet long projecting from the east side of the base into the St. Johns River. At the end of World War II, the United States Navy had 24 battleships, 40 large carriers, 79 escort carriers, 2 battle cruisers, 93 cruisers, 450 destroyers, 359 frigates, and 263 submarines, for a whopping total of 1,310 vessels. Each of these vessels needed a home port to be inventoried, repaired, refitted for deployment, or mothballed. Selected ports along the east coast included Boston, Charleston, New London, New York, Philadelphia, Norfolk, Green Cove Springs, and Orange (just east of Houston, Texas). The Inactive Ships Management Office at Naval Sea Systems Command in Portsmouth, VA, had oversight of this massive undertaking.




Photo Above: Aerial photograph of the mothballed fleet at the Naval Air Station Green Cove Springs on March 29, 1948.

The ships brought to Green Cove Springs were primarily destroyers, destroyer escorts (DE and APD), Troop Transport (LST), and others that arrived between 1945 and 1947. Not only were they docked along the piers, but were anchored in the middle of the St. Johns River, a total of nearly 600 vessels.

Destroyers, DE's, APD's, and LST's were categorized as "Secondary Combatants." As such, only one ship would have a full crew who was responsible for the division. This crew had to divide their work between all the ships to monitor their condition. The primary vessel to which they were assigned could be active in 10 days if needed, and the rest of the division placed in Ready-30 status, meaning they could be reactivated in five weeks.

The mothball fleet grew to a total of 800 vessels as one source states the existence of a photo of all 800 ships in the Green Cove Springs Court House. This notation came from an excellent article written in 2008 by Ken Adams RM2/c for publication in the May edition of the DE History page of the Destroyer Escort Sailors Association (DESAUSA.ORG). Mr. Adams did some research and interviewed locals who had taken part in the mothball operation and provided first-hand information and memories. He also worked with the Clay County Historical Museum. Mr. Adams served on U.S.S. Edsall (DE 129) & U.S.S. Walter B. Cobb (APD 106).

About 150 of the fleet were reactivated when the Korean war erupted, but afterward, in 1962, during the Kennedy presidency, then Secretary of Defense Robert McNamara announced the closing of the Green Cove Springs facility and the move of the entire fleet to Orange, TX. He also announced the closing of 73 other domestic and foreign bases. Speculation is that it was not McNamara but Vice President Lyndon B. Johnson who was responsible for the move to his home state of Texas, but that remains unverified. According to multiple sources, in the rush to move the fleet, many items aboard ships that were not documented were simply thrown overboard. Items such as fuel, peeling paint, transformers, even jeeps, and other equipment may still rest on the river floor below the piers and in the middle of the St Johns River.

In the next few months, maritime archaeologists from the St. Augustine Lighthouse & Maritime Museum will be working directly with the Army Corps of Engineers to survey the area of the St. Johns River around Green Cove Springs. The archaeologists will use sonar equipment to detect potential targets in the river and determine whether these are historic resources for further investigation. Potentially the fieldwork will identify resources from Lee Field as well as the mothball fleet. Stay tuned!





Tips for getting and keeping Younger Members

- Be Honest and Transparent when sending out material to attract new members. Educate
 the younger generation by conveying to them what you have accomplished locally and
 nationally to ensure that veteran issues stay at the forefront of the discussion. Show them
 that you are making a difference. Let them know your whole organization, not just a
 narrow scope of membership and money.
- Treat all veterans equally. Both men and women who have served honorable in the Armed Forces. To assume only men deployed or served is backwards thinking and has no room in the American Legion Family.
- Update posts with free WIFI, offer video gaming like an XBOX or PlayStation and install flat screen TV's and select programming such as sports that appeal to all ages.
- 4. Seasoned Veterans have life experience and perhaps a different frame of reference. We should never think the younger generation is any different. Welcome new ideas younger members are full of ideas. Embrace their energy and let them share ideas about improving the post. Be open to new ideas.
- 5. When you see someone new walk in welcome them with open arms, make them feel like they are part of the post and have found new friends and family. Don't criticize the way they look or their time in service. If you are welcoming they may overlook the stale beer smell and the nicotine stained walls and windows and stay a while.
- 6. Keep meetings short and to the point. Assign younger members a task during the meeting and ask them to work with membership. Get them involved. The younger generation especially millennials like to solve problems by working and teaming with a group. This is a prime opportunity for leadership to mentor those younger members.
- Turn your post into a community type of center. Our younger members want a place that includes their children or to do their homework.
- Turn your post into a place where they can network the community. Invite local business
 owners, company executives, local college Veterans Representatives or members of the
 local Chamber of Commerce to speak at your meetings.
- Don't be afraid to work with others within your community. Build a strong support network.
- 10. If you have a post near a military base begin working with the transition office.
- Introduce yourself to the local Guard, Reserve centers and Recruiters. Most of the members live, work and shop in the community.
- 12. Sign up and attend every veteran event that you can. Make sure the people in your community know that you are the person and post to contact when it comes to supporting veterans and their families.
- 13. It is time to do away with the Old Bar and Night Club look of the Post. Have it bright in the Day time and avoid load music.
- 14. Entertainment should be a way to bring new members, avoid catering to your tastes or keeping something due to tradition try something new and advertise in local papers and through social media.

A Helping Hand for Our Protectors

In addition, it's vital that those sources of help are easy to reach, 24/7. For that reason, OnStar is furthering its commitment to veterans by working with the U.S. Department of Veterans Affairs. When a veteran suffering a crisis pushes the red Emergency button* in their vehicle, OnStar Emergency-Certified Advisors* are able to, if appropriate, connect them with the VA's Veterans Crisis Line. The Veterans Crisis Line offers confidential support that is available around the clock. The VA is also providing additional training to OnStar Advisors to help them determine if a caller may be a military veteran.

"Every moment counts when someone is in crisis and considering suicide," he says. "If there is some opportunity for someone to connect in that moment of crisis, we have an opportunity to save a life."



Are You eligible to file for benefits based on Presumptive Exposure?

Were you exposed to hazardous materials while serving in the military, such as from Agent Orange or burn pits? Did you serve in Vietnam, Thailand or Southwest Asia? If so, you may be eligible to file for service-connected benefits based on presumptive exposure.

Over the course of the last six months, VA has begun processing service-connected disability claims for six new presumptive conditions related to exposure to hazardous materials.

In May 2021, VA started implementing provisions of the William M. Thornberry National Defense Authorization Act for Fiscal Year 2021 (NDAA), adding bladder cancer, hypothyroidism and Parkinsonism to the list of medical conditions presumptively associated with exposure to Agent Orange. A few months later, VA added asthma, rhinitis and sinusitis (to include rhinosinusitis) on a presumptive basis based on particulate matter exposures during military service in Southwest Asia and certain other areas.

Any Veteran who was previously denied service-connection for any of these six conditions but had symptoms manifest within 10 years of military service would need to file another claim. Be sure to use VA Form 20-0995, "Decision Review Request: Supplemental Claim" when filing. The claim form should include the name of the medical condition and also specify that the medical condition is being claimed due to in-service exposure to environmental hazards.

VA is committed to assisting Veterans who may have been exposed to hazardous materials during their military service.

Be sure to stay plugged in to www.va.gov for the most recent developments around environmental hazards; VA is constantly conducting research and surveillance, as well as reviewing scientific literature for conditions that may be related to exposure during military service.

If you feel you have a chronic condition attributed to an in-service exposure, we highly encourage you

to file a claim. For more information about VA benefits and eligibility, or how to file a claim, Veterans and survivors can visit VA's website at www.va.gov or call toll-free at 1-800-827-1000.



What are suicide red flags for veterans?

Veterans commit suicide at higher rates than the general population, but experts say that the warning signs are similar for both groups.

For many, the biggest battles are after they come home...



"Many veterans may not show any signs of intent to harm themselves before doing so, but some actions can be a sign that a person needs help," according to the Veterans Crisis Line, a free, confidential resource to assist veterans. "Veterans in crisis may show behaviors that indicate a risk of self-harm."

The risk factors do not always mean someone is considering suicide. But there are some that require immediate attention, according to the Veterans Crisis Line.

Those include: — Considering or researching ways to hurt or kill yourself — Talking about death, dying, or suicide — Self-destructive behavior such as activities involving drug abuse or weapons

Some other warning signs include: — Frequently sad or depressed — Hopelessness and feeling there is no way out — Anxiety, agitation, sleeplessness or mood swings — Feeling as if there is no reason to live — Feeling excessive guilt, shame or sense of failure — Rage or anger — Engaging in risky activities without thinking — Losing interest in hobbies, work or school — Increasing alcohol or drug misuse — Neglecting personal welfare and appearance — Withdrawing from family and friends — Showing violent behavior — Giving away prized possessions — Getting affairs in order or writing a will

Florida veterans and military families have a new resource to receive the care they need thanks to a partnership dedicated to serving this most deserving population.

Centerstone and the Cohen Veterans Network have joined forces to offer compassionate, targeted behavioral health care for Post 9/11 veterans, National Guard, Reservists, their families and active duty family members at the Steven A. Cohen Military Family Clinic at Centerstone, Jacksonville. https://centerstone.org/cohen-military-family-clinic/jacksonville/. The clinic's skilled clinicians and staff have been trained to work specifically with veterans and their families, and some are veterans themselves. Services offered include individual therapy for children, adolescents and adults, couples therapy, family therapy, groups and workshops.

"Military families are some of the most resilient people you will ever encounter, but a life of service often gives way to invisible wounds and unique challenges that are difficult to navigate," Elizabeth Sherr, clinic director said. "We understand those challenges and stand ready to support our veterans and their loved ones with effective, personalized care right now."

The clinic's ability to meet the needs of veterans and their families quickly is vital in today's mental health environment where gaining access to care can often be daunting - with long wait times and all too common barriers to overcome. The Cohen Clinic at Centerstone is committed to reducing these barriers. Not only are military families currently able to receive same day appointments, the clinic also offers all therapy services via telehealth - breaking down time and distance concerns that can sometimes be problematic.

"We want to make getting help as easy as possible for our veterans and family members," Brigadier General (ret.) Michael Fleming, the clinic's outreach director said. "Sometimes just reaching out for help is difficult enough, and we want to ensure we meet this step with compassion and ease."

For the time being, in an effort to ensure the safety of clients and team members amidst the COVID-19 physical distancing guidelines, that includes conducting all services via CVN Telehealth or telephone. Studies have shown telehealth has the same efficacy as in-person counseling and the clinic's therapists are well trained in the delivery of this care. Additionally, front desk staff still have complete access to answer the appointment line during business hours, as before, and veterans, military families and outside organizations can continue to call directly for an appointment.

Scholarships & Application Deadlines

There are two primary VA Programs offering educational assistance. While federal benefits do not technically have a due date, it is important to apply as early as possible.

The Marine Gunnery Sergeant John David Fry Scholarship (Fry Scholarship) is currently available for children of those who died in the line of duty after September 10, 2001. Beginning January 1, 2015, Fry Scholarship will also be available for surviving spouses of those who died in the line of duty after September 10, 2001.

The Survivors' and Dependents' Educational Assistance (DEA) Program offers education and training opportunities to eligible dependents of Veterans who are permanently and totally disabled due to a service-related condition or of Veterans who died while on active duty or as a result of a service-related condition.

Application Deadlines for surviving children

Children of Fallen Patriots Foundation

No set amount, available for children of those who died in the line of duty or of a service-connected disability. No application due date.

Freedom Alliance

Scholarships of up to \$5,000 for children of those who died in the line of duty. No application due date.

Fisher House Foundation/ Heroes Legacy Scholarship

Amount varies, for children of those who died while on active duty on or after September 11, 2001. Applications available from early December to March 14.

Special Ops Warrior Foundation

Amount varies, for surviving children of Special Operations Service Members who died in the line of duty Applications due at least sixty days prior to the start of the semester.

Deadline for multiple relationships

Army Emergency Relief Fund

Amount varies, for surviving spouses and children of soldiers who die while on active duty or in retiree status. Applications available from January 2 to May 1, 2015.

Application Deadlines: For surviving spouses

Aspire

\$3,000 scholarships per semester for spouses of those who died on active duty. Applications due by October 31 for spring semester and June 30 for fall semester each year.

National Military Family Association

\$500 to \$2,500 scholarships for surviving spouses of those who died while on active duty on or after September 11, 2001. Applications available from December 1 to January 31.

Pat Tillman Foundation

Amount varies, scholarships for surviving spouses of those who died on active duty, in veteran status, or in retiree status. Applications available from February 1 to March 6.

Application Deadlines: For surviving siblings




